### What is this type of insurance?

This is a Healthcare Protect Legal Expenses Insurance Policy, which will protect you in relation to legal disputes. This is a contract between Financial & Legal Insurance Company Limited and the person shown in the Certificate of Insurance. This is a claims made policy, which means that for there to be a valid claim under the policy, claims must be reported to us during the period of insurance.



### What is insured?

- ✓ **Employment Disputes** - Cover is provided for the costs and expenses in relation to the defence of legal proceeding arising from or relating to a breach of an employee's contract of service.
- ✓ **Employment Compensation Awards** - We will pay a basic award and/ or compensatory award which is awarded to an employee by either a tribunal or through the Advisory, Conciliation and Arbitration Service (ACAS), or an amount agreed by us in settlement of a dispute.



### What is not insured?

- ✗ **Advice from Us** - Any claim where the insured person has not followed the advice from Supportis. Advice must be sought before any action is taken against an employee.
- ✗ **Employment** - Redundancy arising within 180 days immediately preceding the inception of this insurance policy.
- ✗ **Employment** - Costs relating to a compromise agreement.
- ✗ **Employment** - Any dispute relating to a shareholding, partnership or directors contract.
- ✗ **Prior Costs and Expenses** - Any costs incurred before a claim is made and any costs and expenses, which we do not authorise.
- ✗ **Dishonesty, Criminal Acts and Fraud** - any claim:
  - Involving actual or alleged dishonesty or violence
  - Or statement, which is overstated, false or fraudulent.
- ✗ **Compensatory Awards** - relating to a finding of direct discrimination, harassment or victimisation.
- ✗ **Unpaid amounts** - due under a contract of employment or under a statutory provision (for example unpaid wages or redundancy payments).



### Are there any restrictions on cover?

- ! **Reasonable Prospects** - There must be more than a 50% chance of you recovering damages, defending a claim or prosecution or obtaining a legal remedy
- ! **Claim** - You must tell us of a claim or any incident that may lead to a claim as soon as reasonably possible and no later than 180 days after the date on which you first knew about the incident.
- ! **Maximum Amount Payable** - The policy limit is £200,000 per insured claim or prosecution. £2,000,000 for all claims and prosecutions brought against you in any one policy year.
- ! **Cover** - This cover is only available via Fish as part of the Healthcare Protect policy and cannot be cancelled without cancelling the Healthcare Protect policy.



### Where am I covered?

- ✓ The Territorial Limits, which are United Kingdom, Channel Islands and Isle of Man.



### What are my obligations?

- Advice - you must follow the advice of Supportis at all times.
- Cooperation - you must cooperate fully with Supportis and us, and provide within a reasonable time, avoiding any unnecessary delays, any requested information and documentation in relation to the claim.



### When and how do I pay?

- You should make payment to Fish Insurance in line with the arrangements of the overall Healthcare Protect Policy.



### When does the cover start and end?

- The Period of Insurance is shown on your Certificate of Insurance.



### How do I cancel the contract?
